WHEREAS, the Saint Regis Mohawk Tribal Council is responsible to protect the health, safety, education and general welfare of all community members; and,

WHEREAS, the Saint Regis Mohawk Tribe is an equal opportunity employer operating under Public Law 93-638 that states in Clauses 17A and 17B that preference be given to Indians for employment openings; and

WHEREAS, Public Law 93-638, the Indian Self-Determination Act of 1977 states that "Preference be given to Indian organizations and to Indian-owned economic enterprises" as defined in Section 3 of the Indian Financing Act of 1974; and

WHEREAS, it has been determine that Indian and Native Preference is sufficient and protects the preference policy of the Saint Regis Mohawk Tribe.

SO THEREFORE BE IT RESOLVED THAT, that the Saint Regis Mohawk Tribe does hereby adopts Tribal Council Resolution #2003 204 which supersede previous Tribal Council #2000-55 and Tribal Council Resolution #1991-54.




WHEREAS, Tribal Council Resolution #2000-55 hereby replaces Tribal Council Resolution #91-52 signed on August 15, 1991.



Goods and services will be purchased from alternative sources if unavailable locally or if quoted costs provided by Mohawk vendors, contractors and service suppliers exceeds ten percent (10%).

WHEREAS, The Saint Regis Mohawk Tribe is the governing body of the Saint Regis Mohawk Reservation.

WHEREAS, The Saint Regis Mohawk Tribe is an equal opportunity employer operating under Public Law 93-638 which states (clause 17 A & B) that preference be given to Indians for employment openings.

WHEREAS, Public law 93-638 (Indian Self-Determination Act - June 1977) states that "Preference be given to Indian organizations and to Indian-owned economic enterprises as defined in section 3 of the Indian Financing Act of 1974 (88Stat.77).

WHEREAS, It is the mandate of The Saint Regis Mohawk Tribe to promote the overall Economic and Employment development on the St. Regis Mohawk Tribal Lands.

WHEREAS, Public Law 93-638 (Clause 33) states that preference be given to domestic source end products (41 US code 10 A-D).

WHEREAS, The Saint Regis Mohawk Tribe has adopted within the Economic Development component (Planning Grant 1991, No. 01-05-15052.91) the following goal:

"To promote economic development through the establishment of quality industrial, commercial and private development, ultimately providing a maximum level of employment among the Mohawk people and surrounding communities which in turn would establish revenue sources for the Saint Regis Mohawk Tribe".






