Tribal Council Resolution 2016 - 77

RESOLUTION OF THE SAINT REGIS MOHAWK TRIBE TO RESCIND TCR 2007-36 FOR MOHAWK PREFERENCE AND ADOPT THE NATIVE AMERICAN PREFERENCE SLIDING SCALE

WHEREAS, the Saint Regis Mohawk Tribal Council is the duly recognized governing body of the Saint Regis Mohawk Tribe and is responsible for the health, safety, education and welfare of all community members; and,

WHEREAS, the Saint Regis Mohawk Tribe is vested with the authority and responsibility for the health, safety, education, and welfare of the residents of the Akwesasne Mohawk Indian Territory; and,

WHEREAS, in TCR 2007-36 the Tribal Council administered the preferential advantage to all Native American vendors allowing them a competitive edge on goods and services from Native American vendors with a 10% preferential advantage; now therefore to be it,

RESOLVED, the Saint Regis Mohawk Tribal Council hereby rescinds TCR 2007-36; be it further,

RESOLVED, the Tribal Council hereby adopts Exhibit A as attached and incorporates herein the sliding scale to support the preferential advantage to all Native American vendors, consultants- contractors, and service suppliers by allowing for a competitive edge in the negotiation process, excluding construction contracts; and be it further,

RESOLVED, the Tribal Council hereby amends the Saint Regis Mohawk Tribe's Procurement Policy Vendor Selection Procedure No. 040 III (1.) to recognize the Native American Preference outlined herein; and be it finally,

RESOLVED, that the Tribal Council hereby adopts the sliding scale for the Saint Regis Mohawk Tribe, including all of its branches, agencies and organizations, to purchase all goods and services through these negotiated cost savings contracts with vendors.
